The undersigned hereby agrees to pay therefore, without demand, the rates established by the Borough for water service.

Water taps up to 2" will be made by the Borough. Water main taps over 2" will be the responsibility of the owner or a contractor hired by the owner. All such taps shall be subject to inspection by the Borough. All excavations and backfilling are the responsibility of the owner or a contractor hired by the owner.
