Sealed Proposals for the “**Body Worn Cameras and Data Storage**” will be received by the Borough of Rockaway at the Town Hall front entrance, 1 E. Main Street, Rockaway, New Jersey on **April 14, 2022**, at **2:30 P.M.**, prevailing time. **After receipt, the bids will be publicly unsealed and the contents publicly announced at the Borough of Rockaway Community Center, 21 Union Street, Rockaway, New Jersey 07866.** Social Distancing must be adhered to, and masks must be worn by all bidders. No Proposals will be accepted after said hour.

There is no charge for the Contract Documents. The Contract Documents may be obtained through email by contacting Kimberly Cuspilich at 973-627-2000, boroughclerk@rockawayborough.org on or after **March 16, 2022**, or in person by appointment only at the Borough Municipal Building, 1 E. Main Street, Rockaway, New Jersey 07866. Prospective bidders shall contact Kimberly Cuspilich to schedule the appointment. The Borough will not be held responsible for contract documents received by any source other than the Borough.

Proposals shall be made on the forms provided and made part of the Contract Documents, which shall be submitted intact. A certified check or cashier's check made payable to the order of the Borough of Rockaway, or a duly executed Bid Bond, in the amount of 10 percent of each bid, but in no case in excess of \$20,000.00 must be deposited by the Bidder together with a Surety Consent evidencing that he can obtain the required Performance Bond and Payment Bond for 100% of the contracted amount. The successful Bidder shall be required to deliver to the Borough an executed Performance Bond and Payment Bond of a responsible indemnity company authorized to do business in the State of New Jersey and listed in OMB Circular 570.

Bidders are required to comply with all of the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27-1 et. seq., the American with Disabilities Act and N.J.S.A. 52:25-24-2 P.L.1977, Chapter 33.

Bidders are also required to comply with other provisions of the law including but not limited to

N.J.S.A. 52:25-24.2 (P.L.1977, C33, Disclosure Ownership)
N.J.S.A. 52.32-32-44 (P.L. 2004, C.57, Business Registration)
N.J.S.A. 34.11-56.25, et. seq. (P.L. 1963, C. 150, Prevailing Wages)
N.J.S.A. 34.11-56.48 (Public Works Contractor Registration)

Proposals must be placed in sealed envelopes and delivered to the Borough of Rockaway, 1 E. Main Street, Rockaway, New Jersey 07866, with the proposal description and the name and address of the Bidder clearly marked on the outside of the envelope.

The Borough of Rockaway reserves the right to reject any and all proposals or to waive any minor informalities or irregularities in the proposal received and to accept the proposal which is in the best interest of the Borough.
